**2. EVENT HOURS TO BE DETERMINED BY EACH EVENT AND OR SPECIFIED IN REGISTRANTS AGREEMENTS. (WACO SHOW: NOON – 7 PM)**

**3. PRE PAID REGISTRATION, EXHIBITOR PACKETS** REGISTRANTS, EXHIBITORS, PARTICIPANTS, VENDORS, CONCESSIONAIRES, VEHICLES ENTRIES, SPONSORS; ADMISSIONS AND DISPLAY SET-UP PACKETS WILL BE MAILED WITHIN 5 DAYS PRIOR TO DAY OF EVENT. OR CAN BE PICKEDUP EARLY AT THE EVENT SITE DURING SET-UP TIMES. PACKETS WILL INCLUDE WRISTBANDS/ENTRY PERMIT, COPY OF REGISTRATION FORM, LOCATION OF SPACE ASSIGNMENT AND ANY ADDITIONAL EVENT INFORMATION. PLEASE HAVE COPY OF PRE-PAID REGISTRATION FORM WITH YOU IN ORDER TO BE LET IN ASAP, ANY EXHIBITORS LATE IN ARRIVING AFTER SET-UP TIMES WILL NOT BE ALLOWED IN TO SET-UP, NO EXCUSES AND NO EXCEPTIONS. **4. SPACE ASSIGNMENT ALLOCATION OF SPACE WILL BE MADE ON A FIRST-COME, FIRST SERVED BASIS.** EXHIBITORS SHOULD NOTE THAT THE EVENT LAYOUT IS DESIGNED TO DISPERSE THE FLOW OF CROWD/TRAFFIC AS EVENLY AS POSSIBLE THROUGHOUT ALL AREAS OF THE EVENT WITH CERTAIN BUSINESSES AND AGENCIES PLACED IN PREDETERMINED AREAS. EXHIBITORS MUST BE READY FOR FIRE MARSHALL INSPECTION AT ANY TIMES OF EVENT TILL CLOSING. ALL VEHICLES OTHER THAN DISPLAY VEHICLES MUST BE REMOVED BY 1 HOUR PRIOR TO EVENT'S PUBLIC ADMISSIONS. ALL EXHIBITS MUST BE READY BY THE OPENING TIME TO THE PUBLIC. **WACO SHOW; SET-UP TIMES 8:00AM TILL 11:00 AM NO EXCEPTIONS!**

**6. EVENT PRE REGISTRATION; BOOTH, CANOPY AND FURNITURE RENTALS** DEPENDING ON EVENT, OUTDOOR EVENT BOOTHS AND CANOPY'S, TABLES AND CHAIRS ARE PRE-ORDERED. PRE-REGISTERED EVENT BOOTHS SET-UP WITH CANOPY'S ARE \$75.00, TABLES \$20 EACH AND CHAIRS \$10 EACH. **DAY OF EVENT, IF AVAILABLE,** BOOTH CANOPY'S RENTALS ARE \$100, TABLE RENTAL FEES \$25.00 EACH AND CHAIRS ARE \$15 EACH. **7. IDENTIFICATION** COMMERCIAL EXHIBITORS WILL RECEIVE PRE-DETERMINED AMOUNT OF WRISTBANDS **PER EACH 10'X10' SPACE (4) AND 10'X20' SPACE (8),** EACH EXHIBITOR MAY ORDER ADDITIONAL IDENTIFICATION WRISTBANDS. THESE WRISTBANDS ARE PROVIDED FOR THE CONVENIENCE OF THE EXHIBITOR AND STAFF FOR IN AND OUT PRIVILEGES DURING EVENT. WRISTBANDS MUST BE WORN AT ALL TIMES TO FACILITATE ENTRANCE TO EVENT GROUNDS. **ADDITIONAL WRISTBANDS MAY BE PURCHASED FOR THE AMOUNT OF GATE ADMISSION PRICE,** WHILE SUPPLIES LAST ON DAY OF EVENT DURING SET-UP TIMES.

**8. PARKING** MUST PARK IN THE PUBLIC PARKING SECTIONS UNLESS OTHERWISE SPECIFIED.

**9. SAMPLING** FOOD AND DRINK PRODUCTS FOR SAMPLING MUST BE APPROVED IN ADVANCE BY EVENT MANAGEMENT. DRINK AND FOOD SAMPLES MUST NOT EXCEED 2 OUNCES AND CONFORM TO EVENT REQUIREMENTS, NO EXCEPTIONS.

**10. CONCESSIONS** THREE TYPES OF FOOD SOLD BY THE EXCLUSIVE CONCESSIONAIRES. **NO FOOD/DRINK SALES VENDORS AT WACO SHOW**

**11. TEARDOWN TIMES** TEARDOWN MAY BEGIN AFTER END OF EVENT ANNOUNCEMENT UNTIL THEN; UNDER NO CIRCUMSTANCES WILL EXHIBITORS BE ALLOWED TO TEARDOWN BEFORE THE SHOW CLOSURE UNLESS APPROVED BY EVENT MANAGEMENT. ALL EXHIBITOR MATERIALS AND EQUIPMENT MUST BE REMOVED FROM THE EVENT SITE WITHIN TWO HOURS AT END OF EVENT, ANY MATERIALS LEFT AFTER EVENT DATE WILL BE DISPOSED OF. LARGE ITEMS, REGISTRANT WILL BE ASSESSED DUMP AND HANDLING CHARGES IF ANY.

**12. HEALTH & FIRE SAFETY** EACH EXHIBITOR IS RESPONSIBLE FOR CODE COMPLIANCE IN ACCORDANCE WITH THE CITY HEALTH AND FIRE SAFETY CODES. THE FIRE MARSHAL REQUIRES INSPECTION OF YOUR EQUIPMENT. FOOD VENDORS MUST PROVIDE A FIRE EXTINGUISHER ON LOCATION. EACH IS RESPONSIBLE FOR SECURING HEALTH AND FOOD HANDLING PERMIT FROM THE CITY, AND PROVIDES A COPY OF PROOF TO EVENT MANAGEMENT. HEALTH AND FIRE MARSHAL WILL BE ON SITE FOR INSPECTIONS, INSPECTING YOUR BOOTH. FAILURE TO PASS INSPECTION IN YOUR PART, YOU WILL BE ASKED TO CLOSE OR COMPLY WITH REGULATIONS. **13. TRASH** ALL TRASH MUST BE TAKEN TO THE DESIGNATED DUMPSTER FOR DISPOSAL. DO NOT USE PUBLIC TRASH CANS, WHICH ARE FOR PUBLIC USE ONLY. FOOD VENDORS ARE RESPONSIBLE FOR THEIR OWN GREASE CHARCOAL WASTE AND CLEANUP.

**14. DAMAGES** RESPONSIBLE FOR ANY DAMAGES ON THE GROUNDS/FLOOR AND ARE REQUIRED TO HAVE GROUND/FLOOR COVERING TO PREVENT DAMAGE FROM OILS, GREASE AND OTHER STAINS. CLEAN UP CHARGES APPLIED FOR DAMAGES TO VENUE'S PROPERTY, A COPY OF THE SIGNED CONTRACT WILL BE FORWARDED TO THE VENUE'S MANAGEMENT AND CITY REQUIRING PAYMENT FOR SUCH COSTS.

**15. CONTRACT** ALL VENDORS AND EXHIBITORS MUST HAVE FULLY EXECUTED CONTRACT AND AGREEMENT WITH FULL PAYMENT ON FILE WITH EVENT MANAGEMENT PRIOR TO EVENT ADMISSION. EXHIBITORS THAT HAVE NOT PAID ALL FEES IN FULL ON DAY OF EVENT WILL NOT BE ALLOWED TO SET-UP AND WILL BE BILLED FOR THE OUTSTANDING BALANCE.

**16. EXHIBITOR PRODUCTS** ONLY ACCEPTABLE PRODUCTS LISTED IN YOUR CONTRACT/AGREEMENT WILL BE ALLOWED, ANY ITEM NOT APPROVED BY EVENT MANAGEMENT IN ADVANCE CANNOT BE PERMITTED

**17. SIGNAGE** MUST PROVIDE THEIR OWN SIGNS; INFORMATION ON SIGNS MUST BE CONSISTENT WITH EXHIBITOR REGISTRATION AGREEMENT. **ALLOWED TO BE PLACED IN EXHIBITORS DESIGNATED DISPLAY AREA/SPACE ONLY, "NO DUCT TAPE, NAILS OR TACS" MASKING TAPE ONLY!**

**18. ELECTRICAL** SERVICES FOR OUTDOOR EVENTS ARE NOT PROVIDED UNLESS OFFERED BY EVENT MANAGEMENT; INDOOR EVENTS MUST BE **PRE-REGISTERED/PRE ORDERED** IN ORDER TO GUARANTEE AVAILABILITY. **WACO SHOWS THE COST OF ONE PLUG 20 AMP OUTLETS IS \$20.** ORDERS DAY OF EVENT AND DURING SET-UP WILL BE CHARGED \$30. SERVICES THAT REQUIRE HEAVY USAGE WILL BE \$50.

**19. SUBLETTING** AGREES NOT TO ASSIGN OR SUBLET THE WHOLE OR ANY PORTION OF THE RENTED SPACE COVERED BY THIS CONTRACT.

**20. INSURANCE** ALL EXHIBITORS ARE REQUIRED TO SHOW PROOF OF PUBLIC LIABILITY INSURANCE. IF YOU DO NOT HAVE INSURANCE, YOU MUST SIGN AN INDEMNIFIER BEFORE SETTING-UP. NOTE: SIGN BELOW

**21. VENDOR/CONCESSIONAIRE/EXHIBITOR CANCELLATION (PRE REGISTERED PRE-PAID)** CANCELLATIONS MUST BE MADE IN WRITING TO EVENT MANAGEMENT. CANCELLATIONS MADE 14 DAYS BEFORE THE EVENT WILL BE ELIGIBLE FOR A 50% REFUND. CANCELLATIONS SUBMITTED WITHIN 14 DAYS ARE NOT ENTITLED TO REFUNDS, NO EXCEPTIONS. EVENT MANAGEMENT WILL HAVE THE RIGHT TO USE THE CANCELED SPACE TO SUIT ITS OWN CONVENIENCE, INCLUDING THE SALE OF SPACE TO ANOTHER EXHIBITOR WITHOUT ANY REBATE OR ALLOWANCES TO THE CANCELED EXHIBITOR.

**22. INCLEMENT WEATHER** DUE TO THE NATURE OF OUTDOOR/INDOOR EVENTS, WEATHER AND ACTS OF GOD MAY AFFECT THE SAFETY OF THE PUBLIC, EXHIBITORS AND OTHER PERSONNEL. REGISTRANTS, EXHIBITORS, PARTICIPANTS, VENDORS, CONCESSIONAIRES, SPONSORS ASSUME THE INHERENT RISKS ASSOCIATED WITH INCLEMENT WEATHER AND ACTS OF GOD. EVENT MANAGEMENT AND OR EVENT ASSOCIATED OFFICIALS RESERVE THE RIGHT TO TAKE APPROPRIATE ACTIONS TO INSURE THE PUBLICS SAFETY, WHEN DEEMED NECESSARY TO HALT OR CANCEL THE EVENT.

**23. SECURITY** WILL BE PROVIDED ON DAY OF AND DURATION OF EVENT TILL TWO (2) HOURS FROM CONCLUSION OF EVENT. **SCI AND NBM**, ITS SPONSORS, VENUE OR AGENTS ARE NOT RESPONSIBLE FOR STOLEN, MISSING PROPERTY, OR DAMAGES WHICH MAY OCCUR BEFORE, DURING OR AFTER EVENT TIMES.

**24. CHARACTER & CAPABILITY OF EXHIBITS** EACH EXHIBITOR MUST BE ABLE TO DEMONSTRATE AN ABILITY TO PROVIDE PROFESSIONAL SERVICE OR SALES CAPABILITY CONSISTENT WITH THE ATTENDANCE PROJECTED FOR THE EVENT. SOUND LEVELS DEEMED DISTRACTING BY EVENT MANAGEMENT, WOULD BE REQUIRED TO LOWER OR ELIMINATE THE SOUND, NO EXHIBITOR WILL BE PERMITTED TO HAVE ANY DISTRACTING ACTIVITIES, WITHOUT APPROVAL BY EVENT MANAGEMENT.

NAME USAGE, ENTRY AND ADVERTISING RELEASE** I HEREBY GRANT THE RIGHT; THE USE OF MY NAME, LIKENESS, VOICE, PICTURES/PHOTOS, PICTURES OF THEIR CARS, BIOGRAPHICAL AND OTHER INFORMATION FOR ADVERTISING, PROMOTIONAL AND RELATED PURPOSES IN CONNECTION WITH THIS EVENT, FOR PUBLICITY, OR THE PROMOTION OF FUTURE ADVERTISING.
